**BOARD OF MADISON COUNTY COMMISSIONERS**  
**July 13, 2023**

On Tuesday, May 23, 2023, a meeting of the Board of County Commissioners came to order at 10:02 a.m. in the Public Meeting Room – Madison County Administrative Office Building, 2nd floor in Virginia City, Montana, with Commissioners Dan Allhands, Chairman, Ron Nye and Bill Todd present. **Salary Increase for Sheriff**

Todd made the motion to increase the Sheriff's salary by 15%. Tilstra noted that this would also have the 6.5% Cost of Living Increase in addition to the 15%. This was acknowledged.
