**General Fund Levy**

Shall the board of trustees be authorized to impose an increase in local taxes to support the general fund in the amount of One Hundred Sixty Thousand Nine Hundred Five Dollars and Fifty-Three Cents (\$160,905.53) per year which is approximately .31 mills, for the purpose of: providing funds to support the General Fund for the proper maintenance and operation of the K-12 Program of the District for the 2026-2027 school year beginning July 1, 2026? Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$0.24, on a home with a market value of \$300,000 by approximately \$0.71, and on a home with a market value of \$600,000 by approximately \$1.51. An increase in property taxes may lead to an increase in rental costs. The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount at least once in the next five years.

Shall the Madison Valley Hospital District (MVHD) be divided into two separate districts, resulting in the creation of a new hospital district called Big Sky Hospital District (BSHD)? The area to be removed from MVHD to create BSHD would be that area of Madison County within the Big Sky Resort Area District, which boundaries shall be as follows:

Commencing at the intersection of the Gallatin-Madison County line and the Township line between Township 7 South, Range 3 East and Township 8 South, Range 3 East thence due west along said Township line to the east boundary of Township 7 South, Range 1 East, thence north along said Range boundary line to the south boundary line of Township 5 South, Range 2 East, thence east along said Township line to the Gallatin-Madison county line, thence due south along said county line to the Point of Beginning.

After the division, the boundaries of MVHD shall remain as its existing boundaries, less the area to be removed to form BSHD. No other changes or alterations to MVHD boundaries shall be made.
